

## NOTICE FOR THE INVITATION FOR BID

NEPAL INFRASTRUCTURE BANK LIMITED (NIFRA), Baneshwor-10, Kathmandu invites sealed bids from registered eligible Nepalese contractors for the procurement of the works as specified below:

The Bid submission is “**One Envelope System**” for construction of Corporate Conference Room at Baneshwor. The bidders have to submit the documentary evidences of minimum eligibility along with their financial proposal and the sealed bid document has to be submitted at NIFRA within deadline.

### 1. Eligibility of Bidders:

The bidders should meet the eligibility criteria and qualification criteria as mentioned in bid document under the section of Eligible bidders. The bidders may require to furnish additional documents and/or information during evaluation of the bidding document. The major eligibility criteria of Bidders are:

- Bidders must have at least three years of experience in the related field;
- Bidders must have completed at least 2 (two) interior/construction related works covering minimum area 15,000 Sq. Ft.
- Bidders must have at least NPR 10 Million Annual Average Turnover in last three years

### 2. Purchase of Bid Document:

A complete set of Bidding Documents can be purchased from Human Resource and Administration Department of NIFRA at Baneshwor, Kathmandu by eligible Bidders on the submission of a written application along with duly notarized copies of below mentioned documents and payment of NPR. 3000 (non-refundable) bid document cost:

- Valid Company/Firm registration certificate;
- VAT and PAN Registration certificate;
- Tax Clearance certificate for FY 77/78 Or Valid time extension letter for tax clearance.

### 3. Bid Submission and Opening:

- Sealed Bids must be submitted to the Registered Office of NIFRA, Baneshwor 10, Kathmandu on or before 12:00 hours on or before of 15<sup>th</sup> day of first publication of this notice. Document received after this deadline will be rejected.
- Bids shall be opened in the presence of Bidder's representatives (who choose to attend) at 14:00 hours on 15th day of first publication of this notice at the office of NIFRA.
- If the last date of purchasing bid form, its submission and opening falls on a government holiday, it shall be extended to the next working day. In such a case the bid validity and bid security validity shall be recognized with effect from the original bid submission deadline.

### 4. Other Information

- Bid must be valid for a period of 90 days after the bid opening and must be accompanied by bid security as mentioned in table above which shall be valid for minimum 30 days beyond the bid validity period.
- Bidders are advised to visit site and assess the actual site conditions before submitting their bid.
- Interested bidders must submit all the documents outlined in the Bid Document and failing to do so shall result in the rejection of the bid. The NIFRA reserves the right to accept or reject, wholly or partly any or all bids for the said works without assigning any reason whatsoever.
